Our facility is located in the heart of Wenatchee (directly across the street from the Chelan County courthouse) at 316 Washington Street. The average daily population was 11.1 for 2015. We have 33 available beds spread over three separate living units. We also have an additional living unit allocated for Secure Crisis Residential Center bed space through joint contract with Children's Administration and the Dept. of Commerce. Phil Jans, Chelan County Juvenile Court Administrator will be out of the office until February 17th and I will need to consult with him prior submitting a draft contract for your perusal. However, in the meantime, I would be pleased to schedule a tour of our facility for your group anytime that is convenient.
